# A litigator should be a specialist in everything that involves a dispute



Interview with

JOSÉ CARLOS SOARES MACHADO

"The combined skills of presentation, argumentation, choosing evidence, and the delimitation of approach, method and strategy create a talented litigator" Mr. Machado discusses the impact of Covid-19 on judicial activity in Portugal, the Portuguese dispute resolution landscape, and how Portugal can become more influential on the global arbitration stage.

LEADERS LEAGUE. How has the Covid-19 crisis affected judicial activity in Portugal? José Carlos Soares Machado. The pandemic caused by Covid-19 has tremendously affected the whole world in all economic and social aspects; Portugal was no exception. The government had to quickly come out with several measures to combat and mitigate the impacts of the crisis. The legal field, including judicial and arbitral activity, were severely affected, since the lockdown measures that were imposed made the courts operate at a slower pace, only judging urgent cases and suspending every "non-urgent" proceeding.

Communications between courts and lawyers became almost non-existent, given the non-existence of trials (either face-to-face or remote). This has been the situation since March 2020; in fact, judicial activity only resumed in September last year. However, given the fact that the pandemic situation in Portugal has worsened exponentially, we have returned to the suspension of deadlines and all "non-urgent" proceedings without any forecast of when we will recommence activity.

# What is the mostly widely used form of dispute resolution in Portugal?

In Portugal we can refer to three mechanisms: arbitration, mediation and judicial proceedings. Arbitration has increased in recent years both nationally and internationally. Mediation is not so common in Portugal. Judicial proceedings are still the most commonly used form of dispute resolution.

# Is it beneficial for litigators to specialize in sectors?

In order to answer this question, it is important to first define what a "litigator" is and stress that the specialization of a "litigator" is litigation: the litigator should be a specialist in everything that involves a dispute, starting with how to present the dispute to the judge, the art of argumen-

tation, the choice in evidence, and the delimitation of approach, method and strategy. All these combined aspects create a talented litigator. On the other hand, it is obvious that greater experience in a specific legal area, due to handling various proceedings and having numerous interventions in similar cases, will give the litigator a valuable asset and advantage.

# What, specifically, does Portugal need to do to become a more influential seat on the global arbitration stage?

I believe that domestic arbitration has significantly developed in recent years. International arbitration has the potential to develop substantially, since Lisbon can be considered an ideal location to host arbitrations. The country has seen an increased number of arbitrations in various areas of law

As Portugal is the world centre of the Portuguese language, many lusophone countries with strong economies, including Brazil and others, are choosing Portugal as their jurisdiction as opposed to the more commonly seen countries such as the USA, the UK and France.

Portugal approved a new law in 2011 to update laws that were put into place over 25 years ago in order to remain relevant on the international stage. The country has a judicial system that is conducive to arbitrations and fully respects the deliberate choice of the parties in choosing arbitration as an alternative means of dispute resolution.

It is also important to emphasise that Portugal has been a member of the New York Convention since 1994, a member of the ICSID since 1965, and a party to more than 60 bilateral treaties, which increases Portugal's credibility and respectability on the international arbitration scene. All these aspects lead me to believe that Portugal is investing more and maximizing its potential in order to become a more influential seat on the global arbitration stage. •
